



The Saticoy Club: 60 Years Of Magical Moments

In the fall of 2016, Bill Apfelbaum and four friends were negotiating to purchase a golf course in Sonoma, California, when their broker informed the group that Saticoy CC might be available for purchase.

A day after getting that notice, Apfelbaum drove to Somis, an unincorporated area in Ventura County, to get a first-hand look at the club, which opened in 1964 with a course designed by famed golf architect William (Billy) F. Bell, son of noted golf architect William P. Bell, who designed such top area courses as Bel-Air CC and Torrey Pines GC. Apfelbaum drove the property with the club president, and it didn't take long for him to experience what many members have termed a "Saticoy moment," an almost mystical feeling created by the beauty of the course.



"It's like you are transported to somewhere away from the rest of the world," Apfelbaum said. "I've been around golf my whole life and I could see the bones of this course were beyond anything I had ever seen. I felt like I had found a Rembrandt that had been hidden away in my attic."

In April 2018, Apfelbaum and the other four Saticoy Partners purchased the club for \$12 million, with the promise to membership to restore the club's luster while maintaining its classic feel and ambience.

CHAMPIONSHIP VENUE

Rebranded as The Saticoy Club by the new ownership, the course has long been considered a hidden gem, with its classic design rivaling other classic layouts such as Riviera CC, Bel-Air CC and The Los Angeles CC. But the club's secluded location in the hills of the Las Posas Valley has contributed mightily to the club's anonymity among the general golf community.

Sitting high on a bluff, surrounded by orchards filled with avocado trees, Saticoy's location offers members a spectacular view of the Pacific Ocean and the nearby Channel Islands as they warm up on the practice range.

This was Ventura County's first private club, founded in 1921 as the Ventura CC. The original club included a nine-hole course designed by William P. Bell and George C. Thomas Jr. that is still around today and is affectionately called "Little Saticoy." The original club was located down Wells Road from the club's current location.

As the membership continued to grow in the early 1960s, they opted to purchase the property the club currently sits on, with work on the course and clubhouse commencing a few years later.

Despite its relative anonymity, over the last 60 years the club has served as host to a plethora of high-level golf events, including multiple U.S. Open qualifiers, the 2008 SCGA Amateur Championship, the 2022 LPGA Mediheal Classic, the Women's Pac-12 Championships, the Ladies California Match Play Championship, The Bruin/Wave Women's Invitational and the Pepperdine Men's Invitational.

And this July, The Saticoy Club will host the 125th SCGA Amateur Championship and 10th SCGA Women's Amateur Championship, which will be held concurrently. Saticoy joins San Diego CC and Goose Creek GC as the only clubs to host these two prestigious tournaments concurrently.

First time being held at The Saticoy Club and in Ventura County, Kevin Marsh claimed his second SCGA Amateur title back in 2008.

A VISION FOR THE FUTURE

As part of their ownership agreement with the membership, the new owners promised to pump money into the club, with the ultimate goal of restoring the 60-year-old design to its pristine condition. The first step was hiring the Arnold Palmer Design Company to handle course renovation, with senior architect Thad Layton tasked with handling the challenge. Layton and Apfelbaum drove the course for two weeks, talking about potential changes and exchanging the vision both had for the course once the work was completed.

Two of the big changes were to the bunkers and the massive trees that filled the property.

"We decided to take out 200 trees and 18 bunkers," Apfelbaum said. "Other bunkers were softened to make them less penal for the average players, but we feel they still have plenty of bite to challenge the top players."

Some of the other renovations included replacing the grass in the fairways, switching from bent grass to Bermuda, seeding native areas to make them more aesthetically pleasing, fixing cart paths, leveling some tee boxes

and adding new Augusta No. 4 sand to bunkers. They also created new tees on holes nine, 16 and 18, giving the club the ability to max out the playing distance to 7,200 yards.

In addition to the course changes, improvements were made to the clubhouse and other member areas, including both the men's and women's locker rooms; the fitness room was updated with new equipment and a new lower terrace, complete with fire pits overlooking the 18th green. An old storage room was converted into a practice area complete with a high-level golf simulator, and a room containing old trophies and other items was transformed into a massage room.

Ron Honeycutt, who joined the club in 1970 and held the course record of 65 for 25 years, said he and the entire membership chose this ownership group for one key reason.

"Yes, they had the money needed to buy and maintain the club, and they had a great vision for the future," Honeycutt said. "But the biggest reason this group was the right one for us moving forward was their integrity. They have gone above and beyond what we asked of them, and the membership could not be more pleased."

A DRAW FOR THE PROS

Over the years, Saticoy's reputation as a hidden gem has drawn an "A" list of golf professionals and celebrities to take on its challenges.

A month after winning the 2022 Masters, Hideki Matsuyama showed up to play a round. As he and Apfelbaum walked to the first tee, Matsuyama asked, "What is the course record?" He was told 64. He proceeded to bogey the first hole and shoot 71.

LPGA major champion Danielle Kang grew up in nearby Westlake Village. As her game began to blossom, the Saticoy members gave her an honorary member-


ship that allowed her unlimited access to the course. Kang admits that she was a bit of a "brat" at times, but she always appreciated the kindness given to her by the club.

"I love Saticoy, and having a chance to practice and play there helped my game develop so much," Kang said. "It's such a great golf course."

To show her appreciation, Kang allowed the club to display her U.S. Women's Amateur trophy in the golf shop during the back-to-back years she was defending champion.

As great as the club's past has been, the owners and members believe the best is yet to come. There are plans in the works to try and build cabins on the grounds, like Augusta National, that would allow the course to offer a stay-and-play element to players outside the area. Apfelbaum even dreams of having a small vineyard to add to the visitor experience.

"It's such a cool place and the membership and staff are so great, it's paradise," Apfelbaum said. "I walk around with a smile on my face and get high fives from people thanking me and our group for doing what we have done. It could not have turned out any better."

AWARDS

Awards for both championships will be presented immediately following the final round. In the event of a tie for first place only, a three-hole aggregate playoff will commence following the conclusion of regular play to determine the champion.





CHAMPIONSHIP INFORMATION

STARTING TIMES AND PAIRINGS

- » Starting times and pairings will be emailed to players and posted online at <u>scga.org</u> the week prior to the championships.
- » The lead group should plan to be at their assigned tee 10 minutes in advance of their starting time. Subsequent groups are encouraged to arrive once the preceding group has teed off. Players arriving late will be penalized under Rule 5.3a of the Rules of Golf. For example, the 9:00 a.m. starting time is defined as 9:00:00, and players arriving after that time are considered late.

PRACTICE ROUNDS

- » Practice rounds are available from June 18 21.
 Additional practice round dates from June 22 July 7
 will be available beginning June 18 at 8 a.m. PST.
- » Players may secure a practice round by visiting the **Practice Round Portal.**
- » Players may only book one practice round. Players may bring a caddie, but the caddie may not play.
- » Fees: \$50 to walk, \$75 to ride.

TEES AND HOLE YARDAGES

- » 125th SCGA Amateur Hole-By-Hole Yardages.
- » 10th SCGA Women's Amateur Hole-By-Hole Yardages.

PARKING AND REGISTRATION

- » Ample self-parking will be available at the club.
- » All participants must check in at the registration table located near the Golf Shop upon arrival on Monday.

DRIVING RANGE

The driving range will open one hour prior to play each day of the championship.

LOCKER ROOM

Players will have access to the club's locker room, which will open one hour prior to play each day of the championship.

DRESS CODE

Appropriate golf attire must be worn, including adhering to any **<u>club-specific policies.</u>**

FOOD SERVICE

- » Players only will be hosted for lunch each day of the championships from 11:30 a.m. to 3:30 p.m. on the Main Patio.
- » Pancho's Place snack bar will open by 6:30 a.m. each day for players, caddies and spectators to make additional purchases. Cash or major credit cards will be accepted.



SPECTATORS


- Spectators are welcome and encouraged to attend the SCGA Amateur & SCGA Women's Amateur Championships.
- Spectators will not be permitted in golf carts.
- » If spectators have any questions leading up to the event, please contact the SCGA Championships & Golf Operations Department at champs@scga.org.

MOBILE DEVICE POLICY

- » Players, caddies and spectators should turn mobile devices off or to silent mode while on the property and limit calls to the club's parking lot.
- Live scoring will be available throughout the championship at scga.org.

AUTOMOTIVE TRANSPORTATION

- » During a round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee (Model Local Rule G-6).
- » Players seeking to use a golf cart due to a medical or ADA-related reason must make arrangements with SCGA staff in advance of the championship.
- » Pull or push carts are permitted.

RULES OF PLAY

- » Prior to participating, participants must review the SC-GA's Policies & Procedures.
- » The <u>Rules of Golf</u> as approved by the USGA and The R&A govern play.

CODE OF CONDUCT

By submitting an entry for any SCGA-administered competition, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from any competition at the discretion of the SCGA staff or Championship Committee at any time before



or during the competition. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered competitions. These include, but are not limited to, the following:

- » Willful damage of the golf course or golf course property
- » Club throwing or unnecessary club tossing
- » Offensive or unbecoming language
- » Public criticism of golf course or verbal abuse of SCGA staff, officials, volunteers, host club staff or other contestants
- » Potential endangerment of others
- » Conduct deemed unbecoming
- » Failure to post scores for handicapping purposes
- » Manipulation of scores posted for handicapping purposes

CANCELLATION POLICY

» To withdraw for any reason prior to the start of the championship, a player must notify the SCGA Championships & Golf Operations Department at **champs@scga.org**.

Refund Policy:

- » Cancelation prior to the entry closing date: Full refund less a \$20 administrative fee.
- » Cancelation after the entry closing date and more than 48 hours prior to the start of the competition: 50% of the entry fee.
- » Cancelation within 48 hours of the start of the competition: No refund.

PACE OF PLAY POLICY

MAXIMUM ALLOWABLE TIME:

The Committee at each competition will determine the maximum allowable time each group is permitted to play the round and each hole. This time will be posted on each player's scorecard, and each player and group is expected to maintain a pace that is faster than the maximum allowable time. A hole ends in stroke play when all players have holed out, and in match play, when all players hole out or the result of the hole is decided. See Rule 23.3c for when a hole is completed in four-ball competition.

IN POSITION:

Groups are expected to remain in position throughout the round. Being in position means:

- » Reaching the teeing area of a par-3 before the group ahead has teed off on the next hole.
- » Reaching the teeing area of a par-4 before the group ahead leaves the putting green of that hole.
- » Reaching the teeing area of a par-5 before the group ahead gets to the putting green of that hole.

WARNING, CHECKPOINTS & PENALTIES:

If a group is over its maximum allowable time and out of position, an SCGA official may issue the group a warning and provide a checkpoint by when the group must regain its position (e.g., within the next two or three holes). If a group receives a warning, it will be monitored by an SCGA official to observe its pace of play.

» If a group fails to regain its position by an established check-point, all players in the group will be informed that the check-point was missed and that one or more players in the group will be liable to receive a one-stroke penalty. The SCGA official will then provide another checkpoint by when the group must regain its position.



» If the group fails to regain its position a second time, one or more players in the group will be liable to receive the general penalty (loss of hole in match play or two penalty strokes in stroke play).

If the Committee identifies that a player (or players) in the group is the cause of the group failing to maintain pace of play and determines other players are playing within the requirements of this policy, those meeting the requirements of this policy may be absolved from penalty while others may.

THE SCGA TOURNAMENT COMMITTEE RESERVES THE RIGHT TO REVIEW ALL PENALTY SITUATIONS.

LOCAL RULES AND TERMS OF THE COMPETITION

The Rules of Golf as approved by the United States Golf Association and The R&A govern play. These Local Rules and Terms of the Competition are in effect at all SCGA championships and qualifying rounds. See applicable championship or qualifying round Notice to Players and Entry Application for modifications or additions to these Local Rules and Terms of the Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2023.

Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty.

LOCAL RULES

OUT OF BOUNDS — Defined by the line between the course-side points of white stakes and fence posts at ground level.

PENALTY AREAS — When a penalty area is defined on only one side, it extends to infinity. When a penalty area is connected to the out-of-bounds edge, the penalty area extends to and coincides with out of bounds.

GROUND UNDER REPAIR – Defined by white lines. French drains are ground under repair.

Ground under repair may include areas of unusual damage but only when so declared by an authorized member of the Committee. When immediately adjacent to an immovable obstruction, such an area is part of that obstruction.

RELIEF FROM SEAMS OF CUT TURF (SOD SEAMS) — Model Local Rule F-7 as prescribed in Section 8 of the Committee Procedures is in effect.

AERATION HOLES – Model Local Rule E-4 as prescribed in Section 8 of the Committee Procedures is in effect.

EDGING GROOVES – Model Local Rule F-19 as prescribed in Section 8 of the Committee Procedures is in effect.

WHITE-LINED AREAS TYING INTO ARTIFICIALLY SURFACED ROADS AND PATHS —White-lined areas of ground under repair and the artificially surfaced roads, paths or other identified obstructions that they are connected to are a single abnormal course condition when taking relief under Rule 16.1.

WOOD CHIPS AND MULCH - Are loose impediments.

INTEGRAL OBJECTS – Include artificial walls and pilings when located in penalty areas or in or adjacent to bunkers.

PROHIBITING USE OF CERTAIN TYPES OF SHOES – Model Local Rule G-7 as prescribed in Section 8 of the Committee Procedures is in effect.

LIST OF CONFORMING DRIVER HEADS – Model Local Rule G-1 as prescribed in Section 8 of the Committee Procedures is in effect.

MISSING PLAYER OR MARKER CERTIFICATION – Model Local Rule L-1 as prescribed in Section 8 of the Committee Procedures is in effect.

PRACTICE — Prior to and after a round in stroke play, a player may practice on the designated practice areas. Rule 5.2b covering practice in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Local Rule, see Rule 5.2.

PACE OF PLAY – See separate memorandum to players for pace of play policy.

STOPPING AND RESUMING PLAY – Model Local Rule J-1 as prescribed in Section 8 of the Committee Procedures is in effect.

All practice areas are closed during an immediate suspension for a dangerous situation until the Committee has declared them open. Players who practice on closed practice areas will be asked to stop practicing; failure to stop practicing might result in disqualification.

An immediate suspension will be signaled by one prolonged air horn note. All other types of suspension will be signaled by three consecutive air horn notes. Resumption of play will be signaled by two short air horn notes.

WHEN COMPETITION IS FINAL:

Stroke Play: When the results and/or qualifiers and alternates have been determined. At championships, when the awards have been presented.

Match Play: When the result of a match has been reported to, and verified by, the committee.

CODE OF CONDUCT* – By submitting an entry for any SCGA-administered event, the contestant understands that his/her participation is at the sole discretion of the SCGA. A contestant may be removed from an event either before or during the event at the sole discretion of the SCGA. Incidents of unbecoming conduct or actions deemed to be detrimental to the image of the SCGA or the "Spirit of the Game" are grounds for such removal and suspension from future SCGA-administered events.

These include, but are not limited to, the following:



PENALTY FOR BREACH OF CODE OF CONDUCT

First Offense: Warning
Second Offense: Disqualification

*The Committee may disqualify a player for serious misconduct in failing to meet the Code's standards.

9TH WOMEN'S AMATEUR RECAP

CHRISTINE WANG PREVAILS AT PAUMA VALLEY CC

In a remarkable display of golf and mental fortitude, Christine Wang emerged triumphant as the winner of the 9th Women's Amateur Championship at Pauma Valley CC.

Entering the third and final round on Tuesday, Wang held a commanding six-stroke lead over her competitors after logging rounds of two-under 70 and five-under 67 on Monday. However, Wang's USC teammate Brianna Navarossa refused to let her secure the championship without a fight.

Navarossa nearly mounted an immaculate comeback that began with a two-shot swing on the ninth hole. Wang's approach shot almost found water behind the green. A par was out of the question, but she was able to minimize the damage with a bogey, while Navarrosa birdied the hole. As the fellow Trojans made the turn, Wang sat at eight-under, with Navarrosa on her heels at four-under.

"Bri is one of my best friends on the team," Wang said. "We're the same year so we came into school together

during COVID so we got really close and we travel to all of our tournaments together. But we're also very competitive with each other because we're close. When we're at school during the season, we have to play qualifying rounds against each other, so this almost felt like one of those."





Each of them bogeyed No. 10. Wang lost another stroke on No. 11 with her third bogey in as many holes, while Navarrosa parred. All of the sudden, Wang's lead had shrunk to just three strokes with seven holes to play.

Then Navarrosa got hot with her flat stick. She rolled consecutive birdies, the first on No. 13 from about 15 feet, then another from off the right fringe of No. 14, over 20 feet from the hole. With four holes to play and one stroke separating the top two competitors, the pressure was palpable.

"On 13 I started to sweat a little bit," Wang said. "Bri made a really good putt from off the fringe and I started to realize 'Okay this is real.' I kind of realized what was happening, that I was in the lead at such a big tournament."

Navarrosa's relentless pursuit nearly saw her catch up to Wang, making for a nail-biting finish to the championship.

The defining moment of the tournament came on the 16th hole. With her lead hanging by a thread, Wang rose to the

occasion and delivered a stroke of brilliance on the 160yard par-3. Her tee shot went right, leaving her well over 30 feet downhill for birdie.

There was no doubt the putt would reach the hole as Wang sent it across the green, and after spinning around the cup a couple times, the ball finally landed in the bottom of the hole for a remarkable birdie that served as a crucial turning point when Wang needed one the most.

"I was definitely not going to leave it short," Wang said. "It was a pretty long putt. My left hip is pretty tight today from all the golf we played yesterday so I kind of got stuck and I held off [my approach shot] to the right. But that putt was downhill, I knew it was fast but I also knew that I at least had to give it a chance and it just so happened I had a good read on it and it just so happened that the hole was there so I think that was a little bit of luck but I was also very pleased."



Navarrosa landed her tee shot on the short side of the fringe with a chip-in birdie opportunity, and nearly converted, but settled for par. Wang's long birdie solidified her lead at two strokes with two to play. But again, Navarrosa wasn't going to make it easy on her teammate.

On the challenging uphill par-5 17th, Navarrosa chipped onto the green and left herself just over ten feet for birdie and converted, while Wang tapped in for par. Navarrosa's tee shot on the par-4 18th found the rough, and her approach landed on the fringe behind the hole, setting herself up for a long downhill birdie opportunity that she needed to convert to have any chance at a playoff.

Wang, nestled on the left side of the fairway, stuck her approach in front of the hole, leaving ten feet or so for birdie. Navarrosa gave her birdie putt a good run, but she ultimately put too much on it. Wang calmy two-putted for par to secure the one-stroke victory, leaving no doubt about her deserving claim to the SCGA Women's Amateur Championship title.

"It was a lot of fun. I played really well," Wang said. "Today I still felt like I was playing well but I think I had a lot of putts that lipped out or were just short. Obviously that made it more interesting coming down the stretch. Especially with my teammate Bri [Navarrosa] playing. She's a great putter."

Wang's triumph serves as a testament to her skill, mental fortitude and ability to rise to the occasion when it mattered most. With the win, she becomes the third USC golfer to capture the Women's Amateur Championship.

"I think the biggest takeaway for me is how I've been really working hard on my mental game," Wang said. "I know my physical game, it's there sometimes, it's not there sometimes. My mental game is something I can always control, so that's been something I've been working really hard at. Today when not all the putts were falling and not all the shots were bouncing in the right direction, having that work that I put in to try and keep calm and take one shot at a time has really paid off and help me stay in my groove and stay focused...I'm super proud of myself."

124TH AMATEUR RECAP

FAIRWAYS, GREENS AND HISTORY

The SCGA Amateur Championship has had 124 iterations and a star studded list of past champions that includes Tiger Woods, Patrick Cantlay, Sahith Theegala and Beau Hossler. But it's never seen a winner like Greyson Leach, who set the all-time scoring (-21) en route to winning by six strokes at Rolling Hills CC. The previous record was held by Rico Hoey (-19) in 2016 at Barona Creek GC.

Leach, who grew up playing at Rolling Hills CC and is a past club champion, did the impossible and made golf look easy over the span of four days at a track he knows very well. Despite being extremely familiar with the property, he still had to execute which, save for three bogeys in his final, he did nearly flawlessly.

Coming into Thursday's final round, Leach held a four-shot lead over his nearest trailer, Krando Nishiba (who shot Rolling Hill CC's course record with a stunning nine-under 63 in round one). By the sixth hole, his already comfortable margin was extended to seven after he carded three early



birdies. The lead could have been bigger, but Leach burned the edge with a six-foot eagle putt on the par-five third hole that just missed going in (set up by a 235-yard 4-iron on his second shot).

Where some players might have felt the pressure of sleeping on an overnight lead, teeing-off late, and being on the verge of capturing an illustrious championship, Leach seemed born for the moment. In his final round, the University of Oregon standout hit 14 of 15 fairways, 16 of 18 greens, and only needed 34 putts to get around a golf course that famously features undulated, multitiered, lightning-fast putting surfaces.

"My putting was the best part of my game this week," Leach said after his final round. "In order to score here at Rolling Hills CC, you need to roll it well. This is best I've ever putted in a tournament."

Over 72 holes, Leach carded 26 birdies and two eagles on his way to a dominating victory that was never in question on Thursday. With a four-round cumulative total of 267, he beat second place by six shots.

"I didn't check the leaderboard until the 16th hole. The entire time I was just worried about myself and staying in my game."

Leach received a hero's welcome at the trophy presentation where members who watched him grow up at the club were on hand to see him make history at his old home course.

"I'm happy to see everyone and I'm glad my family is here to celebrate with me. I can't wait to get in there and share this with all of them."






